

TEMPORARY RESTRAINING ORDER

Plaintiffs' Motion For Temporary Restraining Order came to be heard before this Court on April 27, 2023.

Based upon the Complaint and Petition for Declaratory Judgment, the Affidavit of Dewayne Taylor, and the arguments of counsel, the Court finds that, pursuant to Rule 65.03 of the Tennessee Rules of Civil Procedure, that a temporary restraining order is appropriate based on the Court's findings that Plaintiffs are suffering immediate and irreparable injury, loss, or damage and that immediate relief should be granted. Plaintiffs have advised the Court that they gave oral notice to counsel for Defendant on Tuesday, April 25, 2023, that they would have to file suit if service was not restored this week and also gave notice in writing to Defendant's counsel on the morning the Complaint and the Motion For Temporary Restraining Order were filed.

This Court specifically finds that a Temporary Restraining Order is necessary for the use and enjoyment of Plaintiffs' Property for religious services and related ministry activities, for the housing of residents, and to protect those residents and other ministry recipients who are at risk of losing their sobriety.

THEREFORE, Defendant is hereby ORDERED to:

A. Restore power/electricity services immediately to Plaintiffs' Property, and

B. Maintain power/electricity services to Plaintiffs' Property until this Court orders otherwise.

A Preliminary Injunction hearing shall be held before this Court on May 5, 2023, at 1 p.m.

IT IS SO ORDERED.

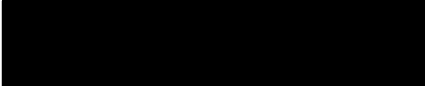
