We also protected religious schools in Maine from discrimination, restoring the right of parents to choose the best education for their children.

Thanks to God's grace and the success we're having, I strongly believe Americans are about to have more religious freedom than they've had in their lifetimes.

I'm confident we can continue winning the fight to

uphold faith and freedom, especially for such a time as this when religious hostility and cancel culture are running rampant across America.

This year has proven that enemies of freedom are relentless, ready to undermine and attack our constitutional foundations at every opportunity. And this battle will only intensify.

But there are special opportunities ahead. And the unparalleled rate of victory we've had this year gives us more reasons to be optimistic. If we can keep working together, there's tremendous hope for the future of our country.

First Liberty Institute has been on the frontlines of the fight for religious freedom since 1997.

First Liberty's vision is to see religious liberty fully protected in law, respected and flourishing in America. Our mission is to advance religious liberty across several key pillars in America: in schools, houses of worship and faith-based organizations, the military and throughout the marketplace and public arena.

2022 marks First Liberty's silver anniversary, one of the most important and impactful years in our history. We had the unprecedented opportunity to fight two major cases at the U.S. Supreme Court.

This is the culmination of years—indeed decades of hard work, dedication, prayer, perseverance and resilience. Most law firms, attorneys and legal organizations can only dream of one day arguing a case before the nation's highest court. We were blessed to not only litigate two Supreme Court cases but to win both in just a single year. The precedent set by these cases will bring transformational change to religious liberty law in America for decades to come. These Supreme Court victories will guard the Godgiven, constitutional rights of the next generation.

Beyond the Supreme Court, we also had a major impact for religious liberty across the country. We defended hundreds of religious Americans who faced harassment, attacks and discrimination because of their religious beliefs. Among a multitude of victories, this year we successfully fought for:

- High school seniors who no longer face censorship because their graduation speeches contained religious references
- A decorated Army chaplain whose career is saved after he was threatened with punishment for living out his beliefs
- An African American church who can keep its property after city officials threatened to take it away
- Houses of worship that are free to safely hold services and no longer face discriminatory pandemic restrictions
- A Jewish congregation who can finally meet inside a private home and not fear punishment by zoning laws
- A Hispanic church that can now open a religious school without harassment from school board officials
- Religious employers who can operate according to their beliefs without the threat of unconstitutional vaccine mandates
- A military veteran's organization who maintains a POW/ MIA remembrance display with a Bible of a WWII hero

These important achievements—and many others that we will share with you throughout this report—are a testament to the growth and transformation of this organization over the past 25 years. The incredible success we've had in 2022 reminds us how far we've come since our inception, when there were just a few staff employees working on a handful of cases. By God's grace—and thanks to the support of millions of Americans nationwide—we remain the greatest hope for victory. For our entire history, we remain the only nonprofit legal organization in the country that maintains a win rate of over 90% across all legal matters.

When we look back at this year, and the more than two decades of First Liberty's existence, we're more encouraged than ever before about the future of religious freedom in our country. The opportunities for impacting religious liberty in America are unlike anything we've seen in decades. Together, we're witnessing history in the making and there's no better time to join First Liberty in the most important fight of our lifetime: the fight for religious freedom.

# FIGHTING AND WINNING TOGETHER.

God will always find people to do His will. I am fortunate that God lets me and others participate in His will at First Liberty. I joined the organization 20 years ago and brought my own computer from home because we didn't have the resources to buy me one. Kelly's plan for conducting legal research was to send me to sneak into the law library at Southern Methodist University.

I will now admit that I did not know anything about constitutional law when I accepted the call to join First Liberty. I had to have my bar review outline on my desk when I started. Kelly would rattle off case names, theories and ideas. I would nod along as if I knew what he was talking about and then go home and research on the internet whatever he was talking about. It was a scrappy time, but a happy one.

But we had big plans. We wanted to take down two cases that for decades caused so much religious hostility, *Lemon v. Kurtzman* and *Employment Division v. Smith.* I am not sure I ever believed we were going to get to where we are today as a movement—*Lemon* finished off and *Smith* on life support.

I certainly did not expect First Liberty to be the tip of the spear. The old building we were in when I started needed the termites to hold hands to keep it standing. But now, after having been to 49 of the 50 states pursuing religious freedom, driving through blizzards, driving on old logging roads in Oregon, climbing a mountain in Montana with our Chief Legal Officer Jeff Mateer to save an old statue of Jesus, and all the other many adventures, all I can say is that it has been a blessing to have been a part of the adventure and to carry on that adventure into the future.

In just the past year, I've seen our team work together to achieve amazing things. To think that in the course of the past year we litigated not one, but two cases at the U.S. Supreme Court is beyond anything we could have imagined. Some organizations and attorneys only dream of reaching the nation's highest court to argue a case. The change and the impact that's happening in our country because of First Liberty is truly incredible.

Winning legal cases is such an important part of the work that we do. But it's not the only part of this battle for our First Freedom. Victories in the courtroom are essential—but what's also equally important is being able to win the hearts and minds of Americans. And First Liberty is fulfilling that mission boldly. We're reaching hundreds of thousands of people with the message of religious liberty, educating them and equipping them with information about the vital role this freedom plays in our society.

Each week, we reach more than half a million Americans through our online and digital campaigns. From updates on our cases to commentary on current events, people across our country are learning how religious liberty is one of the cornerstones of our country. This outreach is also amplified by our continued presence in national and local media. The bottom line is, not a week goes by that someone in America doesn't hear about First Liberty and the work we're doing. To know that I'm part of a team that works so hard to help Americans better understand their freedoms and rights is something I am truly proud of.

# **O** FIRST IN THE FIGHT

It's my privilege and honor to lead First Liberty's incredible legal team. This past year we were hugely successful in our mission to advance religious liberty—in America's schools, houses of worship and faith-based organizations, the military, and throughout the marketplace and public arena. Let me share with you about our success from this past year.

We handled a record number of legal requests, over double the number of requests from the prior year. This surge is not surprising in light of the increased threats to religious freedom for people of faith occurring throughout our nation. Our team met this challenge head on and helped thousands of Americans.

Our victories included two historic wins at the U.S. Supreme Court. In one of the most important religious liberty victories in our generation, *Kennedy v. Bremerton School District,* the Court upheld the right of public high school football coach Joe Kennedy to pray at the 50-yard line after games. In doing so, the Court specifically struck down a 50-year-old precedent that had misguided government officials in evaluating claimed establishments of religion. This significant victory will not only return Coach Kennedy to the football field but pave the wave for greater religious freedom for all public school teachers, coaches and government employees nationwide.

We also obtained an important Supreme Court victory in *Carson v. Makin.* The Court struck down a Maine law that banned families from a generally available student-aid program if they chose to send their children to religious schools. Now parents are free to send their children to the school of their choice even if it's a religious school. This case represents a major win for school choice, parents, students and religious schools.

We also secured a number of preliminary wins for U.S. Navy SEALs and Air Force service members facing punishment for requesting religious accommodations to vaccine mandates. We continue to fight these pivotal cases in federal courts so that our men and women in uniform can serve in accordance with their faith.

We won well over a dozen impactful victories. We successfully preserved a veteran group's Bible display at a VA Medical Center. We protected a college professor who objected to using a student's preferred pronouns that contradicted the student's biological birth. We restored the rights of houses of worship to be a force for good in their communities, including those of an immigrant Irish pastor in remote Walthill, Nebraska, who can once again minister to his community and help revitalize his downtown. We reversed a city's decision to shut down an inner-city church's homeless ministry. We reversed the IRS's denial of tax-exempt status to a faith-based nonprofit. We restored the rights of a Jewish prisoner to receive kosher meals. We put an end to a city's unequal treatment of churches in assessing water fees. We overturned a decision by a city's school committee denying a church the ability to start a religious school. And we successfully defended rights of faith-based organizations, who objected to the federal COVID vaccine mandate for employers with more than 100 employees.

All of these—and many more—legal successes are helping to advance religious freedom across America. While we celebrate these victories, giving God the glory, we know more battles are ahead and our mission is far from over.

### MAJOR VICTORIES AT THE U.S. SUPREME COURT



First Liberty defended Coach Joe Kennedy at the U.S. Supreme Court. Led by our volunteer attorney and former U.S. Solicitor General, Paul Clement, we secured a victory that restored Coach Kennedy's right to pray on the 50-yard line after games. Thanks to this victory, Coach was able to return to the job he loved. It also set a precedent protecting public school employees nationwide.

The Institute for Justice and First Liberty represented several families at the U.S. Supreme Court, challenging the state of Maine for banning them from participating in a student-aid program if they choose to send their children to religious schools. More reasons, more people, more often. These are our goals when communicating to prospective and long-time loyal supporters. Give our donors more reasons to support us, acquire more donors through our different marketing channels and get them to consider giving more frequently.

With a recent shift in how we approach achieving these goals, our main focus started with storytelling. How do we best convey what our latest legal case is about? We put our clients front and center. We make them more relatable to our audience.

For our Coach Kennedy case, we focused on his incredible and inspiring story. Beyond being the coach who was "fired for praying," we sought to tell different parts of his journey, who he is and what makes him the man he is today. That included his military service and the challenges he faced growing up. Most can remember back to when they had a positive and influential coach growing up, a coach that may have changed their lives forever. We try and provide an easy answer...should a coach be fired for taking a knee in quiet, personal prayer after football games? The answer is, no! Can senior citizens have a bible study in the privacy of their own home? Say YES to senior bible studies!

Over the past few years, we have focused on improving our digital efforts. While our web traffic has increased by 96% from the previous year, our digital revenue has grown by over 60%. Additionally, our revenue from recurring gifts has increased by 124%.

Hot off the press...our content is in high demand! We have a fruitful partnership with *The Christian Post*, which reached out to us asking for permission to feature our stories on its editorial page. To date they've shared more than a dozen of our original pieces. This has given us an expanded reach, allowing us to deliver our content to 300,000 more people. That's in addition to our ever-growing audience. In the past year, our total reach through our FLI Insider newsletter has surpassed 500,000.

Our marketing team was also recognized with the 2022 Internet Advertising Competition Award for Best Nonprofit Newsletter Campaign. This is the second time we've received this award and a huge testament to the quality of content we are producing.

This past year, we launched our Supreme Coup campaign, the first and only national campaign designed specifically to educate and energize Americans regarding court reform. No other nonprofit organization in the country besides First Liberty Institute engaged in such a concerted and deliberate effort. This interactive campaign was wholly produced by First Liberty's in-house marketing team, consisting of less than 10 people overall. From building the main microsite, to sharable social content, to creating and aggregating articles, every element of Supreme Coup was designed, crafted and polished by our own creative team.

Our Supreme Coup campaign received two awards: 2022 Internet Advertising Competition for Best Nonprofit Integrated Ad Campaign and 2022 APEX Award of Excellence for Campaign, Programs & Plans in Public Service.

With the goal of educating audiences of the dangers of court-packing, through collaboration with social media influencers, media partnerships, national podcast sponsorships and email outreach, we acquired over 400,000 new potential supporters of First Liberty.

The Center for Religion Culture and Democracy is *First Liberty's burgeoning think-tank initiative. It* is designed to impact the future of religious liberty beyond the courtroom. It brings together elite academic leaders who are shaping cultural debate and thought leadership. The CRCD supports the creation and promotion of high quality scholarship at the intersection of religion, culture and democracy.

Education has always been a critical part of the First Liberty mission, but in October 2020 FLI made the strategic decision to systematize and formalize our commitment to advocacy for religious freedom on every front: in the courts and in the culture.

That is when we launched the Center for Religion, Culture & Democracy (or CRCD for short) to bring our educational and cultural advocacy under one umbrella.

The CRCD contributes to our broad mission in two crucial ways: first, the CRCD seeks to provide educational opportunities on the essential role that religion plays in cultivating freedom and promoting democracy. Religion is not, therefore, merely a part of a healthy society—it is an indispensable, foundational component, which is why religious freedom is so crucial.

Second, the CRCD encourages religious people to take advantage of the freedoms that they enjoy by building and participating in civic institutions, seeking to solve pressing social problems, and contributing to the uniquely civilization-affirming work of faith communities.

To do this work, the CRCD sponsors regular educational programs, publishes an academic journal, supports the research of leading scholars and has launched an annual index measuring and ranking religious liberty protections across all 50 states. The CRCD has assembled a team consisting of some of the field's foremost scholars to work alongside and in tandem with FLI's expert legal team to combat threats to freedom and to present a positive vision for a society that values religious people and institutions.

## RELIGIOUS LIBERTY IN THE STATES INDEX

A Domestic Measure of Statutory Safeguards for the Free Exercise of Religion

In 2022, First Liberty's Center for Religion, Culture and Democracy (CRCD) launched Religious Liberty in the States (RLS), **the first-ever nationwide empirical index of domestic religious liberty.** 

The RLS index is one of our organization's most important educational efforts. We expect this yearly index will make a significant and unique contribution to the research and academic fields. It will bear fruit and impact the national conversation on religious freedom for years to come.

This is a long-anticipated project and a milestone in First Liberty's history, and we are thankful to everyone whose hard work made RLS possible. The RLS index brings together some of First Liberty's and the CRCD's brightest minds, including Jordan Ballor, Ph.D., the CRCD's Director of Research, and esteemed economist Dr. Sarah M. Estelle, the Director of the RLS Project, who tenaciously and tirelessly worked to deliver an important tool that is accessible and transparent.

Our goal is that the RLS index will be enthusiastically endorsed across the political spectrum, by those of any or no faith, in academia and beyond.



RLS is a statistical index and data catalog that measures and ranks religious liberty protections for each of the 50 states. RLS focuses on legal safeguards of religious exercise in state law, both in statute and constitutions. Our researchers and experts examined laws across all 50 states that impact religious liberty.

It is distinct from other religious freedom reports because of the rigorous methodology used. The RLS index identifies 29 distinct items across 11 different safeguards where states have acted to legally protect religious expression and activity. Once aggregated, these 11 distinct areas produce one RLS index score per state, suitable for ranking states and, in time, tracking changes.



### WHY DOES IT MATTER?

This index is a critical initiative that will help millions of Americans better understand their legal rights, especially where they live. While the First Amendment broadly protects every person's right to the free exercise of religion at the national level, RLS captures and communicates how many safeguards each state has in place for religious exercise. This index will aid citizens as they compare how states are doing relative to one another and how each one measures up to the potential safeguards it could provide. Every state has room for improvement, and this report will help identify where states can improve.

First Liberty won a major victory at the U.S. Supreme Court on behalf of our client Coach Joe Kennedy. Seven years ago, a school district in Washington fired him for praying on the 50-yard line after football games. We represented and fought for Coach Joe through an arduous legal battle—a case that went up and down the courts several times. Now, we're celebrating a historic win!

The Court issued a landmark 6-3 decision upholding his right to take a knee in quiet, solitary prayer. But this wasn't only a victory for one coach in Washington state. It has a nationwide impact on public-school teachers, employees and coaches, who are now free to live out their faith in public. This win overturned a prior ruling that harmed religious freedom for decades and set a major precedent for moving forward. Thanks to this win, you and millions of Americans have more religious liberty in more than 50 years.

Many people know Coach Kennedy as the "kneeling football coach." But there's so much more to his story. Behind the big smile and gregarious personality is a journey of resilience, courage and perseverance.

After a difficult childhood that included moving in and out of foster homes, Coach Kennedy sought discipline and stability. This led him to serve his country in the armed forces for 20 years, most of that time in the U.S. Marine Corps. His service included two deployments during Operation Desert Shield and Desert Storm.

While overseas, he witnessed what the absence of religious freedom looked like. This experience gave him a greater appreciation for the freedoms we enjoy here in America. It also gave him a first-hand perspective of why we cannot take our constitutional rights for granted.

As a Marine, Coach Kennedy took an oath to protect the Constitution. But fighting on the battlefield was only one part—indeed, only the beginning—of his duty and service to his country. Not long after leaving the service, he'd once again be called to defend the Constitution. Although this time, he wouldn't be wearing a military uniform.

Many people often ask: Why did Coach Kennedy kneel to pray in the first place?

In 2008, Coach Kennedy returned home from military service and got connected with the local football team. But it was not something he sought out. One day, while out for a run, someone driving by asked him if he had any experience coaching. He told that person about his military service and that he thought he could use what he'd learned in the service to be a coach.

When he became a football coach at Bremerton High School in Washington state, Coach made a personal commitment to God. After every football game—win or lose—he would take a knee to pray for his team and thank God for the opportunity to be a coach. So, at his inaugural game, Coach Kennedy knelt on the 50-yard line for a brief, personal prayer.

For seven years, Coach Kennedy prayed on the field without receiving any complaints. Shockingly—after a

compliment from a school administrator from a visiting team—the Bremerton School District prohibited him from engaging in "demonstrative religious activity." They told him any religious expression would have to be done where nobody could see him.

Coach Kennedy was not going to renounce his commitment simply because government officials told him to stop praying. He was not going to back down simply because opposition came his way.

As a combat veteran, Coach Kennedy knows firsthand the sacrifices one must make to protect the liberties we cherish—especially the right to freely live out one's faith. Not praying on his own after games would mean breaking his commitment to God and forfeiting the liberties he defended.

He had to live up to what he'd learned as a U.S. Marine: *semper fidelis*—always faithful. So, he continued to pray, and in 2015, the school district fired him.

Despite the consequences, he knew, deep down, staying true to his faith was the right thing to do.

Coach Kennedy braved nearly seven years of litigation. His case went up and down and back up again through the federal courts. Despite numerous setbacks, his courage and tenacity eventually brought him to the highest court in the land. And now, we're celebrating a victory for Coach and a victory for religious freedom.

Looking back on Coach Kennedy's journey, it's clear the many adversities he faced in life—from his tough childhood to his military service—prepared him to take a stand for his constitutional rights, as well as for the rights of all Americans.

We applaud and commemorate Coach Kennedy for his heroic perseverance, both on the frontlines of war and on the legal battlefront. Time after time, this Marineturned-football-coach has led by example, showing us that we must never back down in our commitment to God and country.

### WHO ARE OUR CLIENTS?

They're America's everyday heroes. They're courageous people of faith like:

### **GAIL BLAIR**

An elderly blind woman who wanted to share her faith. Local officials banned her from the public park and threatened her with arrest for handing out a small tract of the Gospel of John to those who wanted one. First Liberty stepped in to stop this blatant discrimination, and she can now indefinitely walk by faith and not by sight. Gail's victory means that no American-least of all a gentle, blind woman-should be banned or censored for simply carrying on a conversation about faith in a public park.

### **JARVIS BAKER**

Pastor of Canaan Baptist Church. City officials attempted to seize his small church's property through eminent domain. The reason? The city wanted to build a fire station-when a fire station already existed right across the street. First Liberty stepped in to stop this assault resulting in the city announced it would not strip away the church's property. This means Pastor Jarvis Baker and his congregation are free to continue worshipping and using the property to serve their community.

### **RABBI RICH**

Who leads Congregation Toras Chaim, a small Jewish congregation that endured a five-year legal battle with city officials over alleged violations of parking regulations...even though members of the congregation do not drive on the Sabbath. First Liberty reached a settlement to secure a victory and stop the city's harassment.

### **DANIELA BARCA**

A 14-year-old high school freshman who wanted to form a club with other students who shared her Christian faith, but school officials refused to approve her club simply because it was religious. After First Liberty's intervention, school officials reversed their position, allowing Daniela's club to meet and give students an opportunity to encourage one another.

### PAUL MALCOLMSON

Pastor of Light of the World Gospel Ministries. Pastor Paul is a former Northern Ireland police officer who traveled across the Atlantic Ocean to serve a village with a population of about 800. We represented the church in a lawsuit against local officials over denials of building and use permits. First Liberty reached a favorable settlement that will allow the church to build a multi-use facility for worship, ministry and commercial space to serve all village residents.

### LACEY SMITH

A dedicated flight attendant. Alaska Airlines fired her for expressing her religious beliefs. First Liberty filed suit in federal district court against the airline, arguing that it violated federal civil rights law that prohibits religious discrimination. A win for Lacey could help ensure that religious Americans are not forced to choose between their faith and their livelihood.

### **DR. ERIC WALSH**

A public health expert who served on President Obama's Presidential Advisory Council. Dr. Walsh, a lay minister at his church, was fired from his position as a health director because he preached about traditional marriage in a sermon. We secured a victory for him, a key step to help ensure that no American should be fired for living out their faith.

### **U.S. NAVY CHAPLAIN WES MODDER**

Former chaplain for Navy SEAL Team Six. He nearly lost his job, pension and retirement benefits. Why? He answered questions about his church's teaching on marriage in a private counseling session. First Liberty intervened, and Chaplain Modder was exonerated.

First Liberty Institute launched Supreme Coup, a comprehensive, multi-faceted digital campaign to educate millions of Americans on court-packing.

Supreme Coup is the first and only national campaign designed specifically to inform Americans regarding court reform. No other nonprofit organization in the country besides First Liberty Institute engaged in such a concerted and deliberate effort.

In this major educational initiative, First Liberty created multiple resources and content about the history of court-packing in the United States, as well as in other countries. Combined with the expertise of our legal experts and attorneys, we commissioned a group of renown scholars who researched and published a robust white paper. This was a key informational component that we distributed to thousands of Americans.

We combined this quality resource with articles and op-eds published on a regular basis. This was to ensure as many people as possible could consistently be given the information and history of court-packing, as well as the reasons why this proposal is a threat to our nation. From President Franklin Roosevelt's failed attempt to pack the Supreme Court in the 1930s to modern day, our experts discussed at length how court-packing leads to the destruction of civil rights and freedoms, including religious liberty. We amplified our message and explained the dangerous consequences of court-packing, such as how it would end the legitimacy of the U.S. Supreme Court, destroy our Constitution's founding principle of separation of powers, politicize the courts and erode all public confidence in future court rulings.

Through Supreme Coup, First Liberty built and activated a grassroots coalition of diverse allies across the country. We garnered the support of national leaders and organizations, including:

## STEWARDING OUR **BLESSINGS**

The past couple of years have been an incredible period of growth for First *Liberty Institute.* 

*People from across America increasingly* realize the importance of religious liberty to our country. And they are more motivated than ever before to join forces with our organization in this critical effort.

Thanks to the generosity of thousands of Americans, First Liberty now reaches millions of people with our message and directly assists countless others who face attacks because of their faith. Because of this burgeoning demand for help, we hired six additional world-class attorneys, and attendant support staff, to litigate the flood of new religious liberty cases; a few of these legal matters may well be headed to the United States Supreme Court for resolution in the coming years. As you see from the data on the next page, for our fiscal year ending June 30, 2022, we continued to show record increases in financial

support and the demand for our services. Careful and proper financial stewardship of our resources is an integral part of our overall business strategy. Ours is a human capital-intensive enterprise, and we hire the very best people we can afford. Therefore, we strive to maintain an appropriate balance between our programmatic elements and necessary administrative and fundraising efforts. In FY2021 for example, we had a record year financially and in our legal and educational impact. In fact, 80% of our FY2021 expense budget supported our legal and educational programmatic elements. In that year, and so far this year, our balance sheet expanded nicely, and our overall sustainability posture continues to increase. I believe both will be even higher for FY2022 once our independent auditors issue their report for that year.

I'm excited about what the future holds for First Liberty. Our legal cases are shaping the law, and our educational and informative materials are before millions of our fellow citizens. Yet, there are so many more opportunities that are presenting themselves; initiatives that we thought would have been impossible in years past. This coming year, we expect to launch several new innovative programs that promise to expand our reach even further and fight the good fight to preserve our religious heritage. Stay tuned!
