JUDGES EITHER PROTECT OR RESTRICT OUR FREEDOMS

Since 2016, the U.S. Supreme Court has issued several opinions protecting religious liberty, free speech, and life. These victories occurred because a majority of the U.S. Supreme Court justices voted to uphold the constitutional rights of all Americans. Without them, many of the following cases could have turned out very differently.

Religious Freedom Victories Since 2016

- Protecting the right of a football coach to kneel and pray after football games.¹ [First Liberty case]
- Protecting a cross-shaped veterans memorial.² [First Liberty case]
- Protecting religious school choice. ³ [First Liberty case]
- Protecting the religious freedom of employees in the workplace. 4 [First Liberty case]
- Protecting faith-based foster care. 5

Life & Free Speech Victories Since 2016

Protecting a wedding website designer and a wedding cake artist.⁶
Overturning Roe v. Wade.⁷
